

#### OCR On-Site Review Schedule Planning Post-secondary

The on-site schedule can occur in a sequence that takes advantage of the college's schedule. It is helpful but not necessary that all the meetings occur within three consecutive days. Meetings with individuals and groups typically last between 30 and 60 minutes. We will negotiate the schedule well in advance of the visit. On-going communication between staff from the college and the State MOA Coordinator from NHDOE is essential for a successful review. The college is encouraged to designate a key person to handle communications with the State MOA Coordinator to streamline the review process.

#### Review of Facilities

The facilities state reviewer team will need to review both sites in the company of someone who can answer relevant questions, such as the Facilities Director or representative. The facilities review will take place on the first day of the schedule.

#### Interviews

During the course of the day, the state review team will need to meet with a variety of people and groups. The review team will need a place to work in privacy during this time. A sample schedule is on the next page to serve as a starting point and includes appropriate durations for each meeting. We have 15 minutes working breaks between interviews to compile notes and prepare for the next interview. Regardless of how the day is scheduled, the following groups need to convene:
